ADVANTAGES

Affordable Hunting Lease Liability Insurance is available to each member of the National Wild Turkey Federation (NWTF) on land owned by the members, which is leased to a hunt club. NWTF is accepting applications for coverage under its one-year group policy, which will become effective March 1st and will remain in effect until next March 1st or July 1st and will remain in effect until next July 1st.

REQUIREMENTS

- ⇒ This policy names both the landowner and the hunt club as insured and each receives a Certificate of Insurance, so both must be a member of NWTF.
- ⇒ There must be a written lease agreement between the NWTF member landowner and the hunting

Each distinct ownership, whether individual, partnership, trust, corporation, etc., must maintain a membership in NWTF and qualify separately for insurance coverage. If you lease from different landowners, each owner must be a member and a separate landowner application must be filled out.

NWTF's group insurance policy is for landowner members and hunt clubs. This coverage is designed to cover the hunting club's activities on any NWTF member's land leased to the club. Any land that is subleased may not be included.

NOTE: This program offers broad coverage, but the insurance is strictly "Hunting Lease Liability Insurance" and does not take the place of liability insurance coverage unrelated to lease hunting activities. Activities such as commercial dove shoots and short-term fee hunting are not covered.

NWTF MEMBERSHIP DUES

POINTS TO REMEMBER

This program is only available to NWTF members in good standing. Both the Hunting Club or Club Representative and the Landowner must be current/new members of NWTF to qualify.

Policy Effective Dates are March 1st to March 1st or July 1st to July 1st.

(If payment is received after March 1st or July 1st, your coverage becomes effective on the date that your payment is received until next March 1st or July 1st.)

About NWTF

The National Wild Turkey Federation is a national non-profit conservation and hunting organization that, along with its volunteers, partners and sponsors, has worked for the conservation of the wild turkey and preservation of the hunting tradition. When the NWTF was established in 1973, there were only 1.3 million wild turkeys. Today that number stands at more than seven million birds throughout North America, and hunting seasons have been established in 49 U.S. states, Canada and Mexico.

History of NWTF

In 1973, Tom Rodgers founded the National Wild Turkey Federation in Fredericksburg, Va., as a national 501(c) (3) nonprofit conservation and education organization with a mission dedicated to conserving wild turkeys and preserving hunting traditions. Shortly thereafter, Rodgers relocated the NWTF to Edgefield, S.C., where it's still headquartered today.

At the time the NWTF was established, there were only 1.3 million wild turkeys. Today that number stands at more than seven million birds throughout North America, thanks to the efforts of state, federal and provincial wildlife agencies, the NWTF and its members and partners.

Growth and progress define the NWTF as it has expanded from 1,300 members in 1973 to nearly a half million today. With that growth has come impressive strides in wildlife management as the NWTF has forged dynamic partnerships across the country to further its conservation mission. Together, the NWTF's partners, sponsors and grassroots members have raised and spent more than \$286 million upholding hunting traditions and conserving nearly 14 million acres of wildlife habitat.

While wild turkey restoration is nearing completion, the NWTF still has much work to do. Across North America, supporters are working to enhance habitat for wild turkeys and other wildlife while providing hunters with more opportunities and access to public and private land. In addition, NWTF volunteers and partners are introducing youth, women and people with disabilities to the outdoors through special educational events.
