



## FEDERAL PREMIUM AMMUNITION- DIRECT SALE FOR NWTF JAKES SHOTGUN PROGRAMS

**WHAT QUALIFIES:** Events and programs must be Chapter sponsored and publicized JAKES events. Youth Days, Outdoor Skills Programs, Mentored Hunts. Chapters that sponsor youth shooting teams through 4-H, AIM, SCTP or other local programs may also participate. Ammunition is NOT for re-sale, and limited to youth programs only.

**SHIPPING TIMES:** How long it takes for you to receive your ammo order varies on several factors. You should always expect orders to take 4 weeks minimum to arrive. For spring and summer programs, we recommend placing orders prior to February 1- this gets your order in ahead of the major sales shows. Ordering in December can often get you in ahead of January 1 price increases. Waiting until March or later often results in delays of 6 weeks or more. Market conditions (high consumer demand) can also cause ammunition to be backordered.

**AMMUNITION TYPES:** This program is for trap loads only.
